3. BACKGROUND AND RELATED WORK

Explain the specialized and relevant related background necessary to appreciate the work. Include references to the literature where appropriate, and briefly describe how your work is different from related work.

4. APPROACH AND UNIQUENESS

Describe your approach in attacking the problem and how it is novel. Your hypothesis may be here.

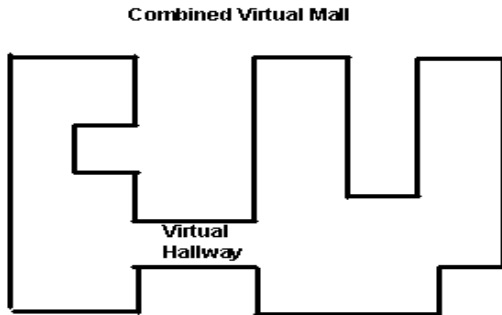


Figure 1. Place caption below figure.

Internal technical reports may be cited only if they are easily accessible (i.e., you can give the address to obtain the report within your citation) and may be obtained by any reader. Proprietary information may not be cited. Private communications should be acknowledged, not referenced (e.g., “[Robertson, personal communication]”).
